Dear CSG West Executive Committee Members,

The CSG West Nominating Committee is accepting applications from Western legislators interested in serving as an officer of CSG West. The position of 2020 Vice Chair will be open and the legislator that is elected by the Executive Committee will succeed to the position of chair in 2022.

All applicants will be scheduled for an interview with the CSG West Nominating Committee on Wednesday, July 17 during the 72<sup>nd</sup> CSG West Annual Meeting in Big Sky, Montana. The CSG West Rules specify that only legislators that are members of the **Executive Committee** are eligible for election as officers. Moreover, as required by the Rules, in order to maintain party balance among the officers, this year the nominating committee will be interviewing **Republican** legislators who are interested in serving as an officer of CSG West.

The Nominating Committee, upon finalizing its process, will recommend a slate of 2020 officers to the CSG West Executive Committee. The deadline for receiving applications from all interested and eligible legislators is **Tuesday, July 2**.
