Dear Chairman Gowdy and Ranking Member Cummings:

The Council of State Government (CSG) is a regionally-based national organization serving all three branches of state government. Advocating the interests of states in our federal system of government and furthering the relationship between states and the federal government is a key priority for the organization.

Over the last year and half CSG, both regionally in the West and nationally, has been part of a coalition of multi-branch and bipartisan organizations representing state and local government officials working to realign the state – federal relationship. These efforts, which included the adoption of joint principles of federalism, have resulted in substantive engagement and the sharing of ideas with several federal agencies and members of Congress.

We have been pleased with the engagement of many federal agency officials to have meaningful dialogue with state and local government associations to address issues of concern while soliciting input to improve the state – federal partnership. To this end, we believe Congress can play a significant role in promoting a more functional and effective system of federalism for the benefit of our shared constituents.
